

RICH INDUSTRIES, INC.'S LIMITED WARRANTY

Rich Industries, Inc. warrants to the purchaser that the suits and other items manufactured by Rich Industries, Inc. and included in the packages offered for sale conform to the standards described on the "Product Description" page of this website and are free from defects in material and workmanship, *provided* that the item (1) has been stored, used, and maintained properly in accordance with all written instructions and recommendations provided with the product; and (2) has not been damaged, altered, modified, or repaired by any party other than Rich Industries, Inc. To the fullest extent permitted by law, the limited warranty set forth on this page is the exclusive limited warranty, and in lieu of any other oral or written warranties or representations.

How Long Does the Coverage Last?

This limited warranty lasts for one (1) year from the date of purchase, or until you sell or otherwise transfer the suit, whichever comes earlier. Coverage terminates if you sell or otherwise transfer the item.

The duration of any implied warranty, including the warranties of merchantability and fitness for a particular purpose, shall not exceed the duration of this written limited warranty.

What Will Rich Industries, Inc. Do?

In the event that Rich Industries, Inc. should determine within the warranty period that the item purchased is defective under the terms of this limited warranty, the

purchaser's sole and exclusive remedy will be that Rich Industries, Inc. will, at its option, repair or replace any defective or malfunctioning item at no cost to you. Within the warranty period, if Rich Industries, Inc. is unable after a reasonable number of tries to repair the defective item, it will replace it with the same or a similar item.

What Does This Warranty Not Cover?

Any problem that is caused by abuse, misuse, or an act of God are not covered.

Rich Industries, Inc. makes its best efforts to include just the right component parts in its packages. Some of the components selected are sourced from manufacturers other than Rich Industries, Inc. Parts and products which are manufactured by companies other than Rich Industries, Inc. and which are covered by a written warranty from the manufacturer of that part or product are not covered by this limited warranty. If you purchase a part or product manufactured by a company other than Rich Industries, Inc. which is covered by a written warranty from the manufacturer, a copy of that written warranty will be provided to you by Rich Industries, Inc.

To the fullest extent permitted by law, Rich Industries, Inc. shall not be liable to the purchaser, end user, or any third party for any indirect, special, incidental, or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

How Do You Get Service?

If something goes wrong with your item, send it postage prepaid, including a copy of the original receipt or invoice and a brief written description of the problem to:

We will inspect your item and contact you promptly to give the results of our inspection. If you authorize repairs, we will return the repaired item to you promptly. The cost of shipping the repaired item back to you will be paid by Rich Industries, Inc.

If you inform us that you wish us to provide necessary parts to you, but that you wish to have repairs performed elsewhere, we will return the suit and/or replacement parts to you promptly.

There is no charge for inspection.

How Does State Law Apply?

This limited warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
